## [Guido Bünstorf appointed to the Expert Commission on Research and Innovation \(EFI\)](#)

On August 10, 2022, INCHER board member [Professor Guido Bünstorf](#) was appointed by the German government as a new member of the five-member [Expert Commission on Research and Innovation](#) (EFI). EFI provides scientific policy advice to the German government and submits an annual report on Germany's research, innovation and technological performance. In addition to analyzing key issues of the German research and innovation system, options for action and recommendations for further development of the German research and innovation system are central elements of EFI's work.

At the same time as Guido Bünstorf, Friederike Welter (President of the Institute for SME Research, Bonn) became a member of EFI.

Commenting on his appointment, Guido Bünstorf states, "Research and innovation policy is facing extraordinary challenges in light of the major crises our country is experiencing. Research and innovation are seen as key levers to meet these challenges, yet there is no blueprint for how policymakers should proceed."

[Uwe Cantner](#), EFI's long-time chairman, is looking forward to the collaboration: "With Guido Bünstorf and Friederike Welter, we have gained two excellent experts. Their expertise will not only enrich our scientific work, but also provide new, implementation-oriented impulses, especially for the exchange with politics".

Guido Bünstorf is Professor of Economics at the University of Kassel, heading the [Economic Policy, Innovation and Entrepreneurship group \(EPIE\)](#). He is also a member of the INCHER board of directors.

## "A step into the future": INCHER is part of the competence network bibliometrics (Kompetenznetzwerk Bibliometrie)

Bibliometrics analyzes scientific publication activities and thus provides data on the scientific communication process, which is of great importance for research. In order to make bibliometric data available in a research-related and comprehensive form, the German Federal Ministry of Research and Education (BMBF) has established the Competence Network Bibliometrics. The INCHER of the University of Kassel is one of the leading institutions of science and university research in Germany belonging to this network.

An important problem for research with bibliometric data is that they are owned by large scientific publishers or other companies and cannot be readily used for research. To address this problem and thus open up new perspectives for higher education and science research in Germany, the Federal Ministry of Research and Education (BMBF) has now launched the Bibliometrics Competence Network. This competence network brings together the leading institutions of science and university research in Germany. In the future, they will be able to access the central bibliometric databases via a joint license. The International Center for Higher Education Research (INCHER) at the University of Kassel is also a member of the Bibliometrics Competence Network.

"We are very happy to be able to do internationally competitive cutting-edge research with bibliometric data on this basis," says Professor Guido Bünstorf, who represents INCHER in the competence network. His colleague Dr. Johannes König, who is also involved in the competence network on behalf of INCHER, adds: "The data that are now available will allow us to apply complex artificial intelligence techniques to ask entirely new research questions. Membership in the competence network is therefore a step into the future of INCHER."

## Congratulations on your 80th birthday Ulrich Teichler!

Professor [Ulrich Teichler](#), the long-time director of today's INCHER and founder of German-language higher education research, has turned 80 years old in July 2022.

Ludwig Huber once called him the "Hercules of higher education research", others have called him "the old guru" (Katja Rudolf in the HNA of 16 November 2020) or even XXL higher education researcher ("Who fits Teichler XXL?", DUZ v. 19.12.2008). All of this fits wonderfully and then again not. One thing is certain: without Ulrich Teichler, university research in Germany would be unthinkable as it is. Besides him being the founding director of INCHER and the motor behind many developments in German higher education research, he is also the generous benefactor of a prize for young researchers in higher education research, which has been awarded annually since 2008 for outstanding doctoral theses and dissertations.

He has shaped research at INCHER (formerly WZ I) at the University of Kassel with never ending energy and an analytical eye with always surprising perspectives. His humor, openness, internationality and hospitality have made INCHER a place with a very special working atmosphere.

Ulrich celebrated his 80th birthday in a restaurant in Kassel, together with many guests from Kassel and the surrounding area and some from further away. In his speech he said: "This celebration today is an opportunity to look back with joy on a long life. It has certainly not been free of sorrows, and I have certainly made some mistakes. But I have also had many positive experiences. I have been able to make many friends. Thank you for being with me today!"

Three books by Ulrich Teichler were published just in time for his 80th birthday ([see below](#)). One of them is: Teichler, Ulrich (2022): [Higher Education Research - What Else? The Story of a Lifetime in Conversations with Anna Kosmützky and Christiane Rittgerott](#). Leverkusen-Opladen: Budrich. In this book, Ulrich looks back on more than five decades of higher education research in this book. ## From INCHER research projects

### Review of the activities of the DFG-funded research group "Multiple Competition in the Higher Education System" in 2022

In 2022, the research group "[Multiple Competition in the Higher Education System](#)" entered its 2nd year. The locally distributed research group, coordinated by INCHER, clarifies how actors position themselves in competition, what dynamics multiple competition unfolds in its various manifestations and at the different levels of the higher education system, and what consequential effects it has. This year's focus has been and continues to be the empirical survey in the eight individual projects as well as the work on the theory of multiple competition and interdisciplinary networking.

Several workshops are particularly noteworthy for the work in the research group:

The first in 2022 was a workshop organized by Anna Kosmützky, Leonie Buschkamp and Tobias Bochmann ([LCSS, University of Hanover](#)), where researchers from the sociological projects presented and discussed their PhD- and habilitation projects.

In spring 2022, a workshop in Hofgeismar near Kassel followed. Here, the state of research in the individual projects was presented and coordinated, as was the empirical procedure in the projects. An additional focus lies on interdisciplinary theory development, since the systematic development of a theory of multiple competition is, further to empirical research, also a major goal of the research group.

This event was followed by a workshop organized by Hanna Hottenrott, Thomas Schaper and Julian Schwierzy ([TU Munich](#)) on the Heilbronn campus of the TU Munich, where many researchers from the DFG research group presented and discussed their results with relevant researchers like Gili Drori, and plans for the application of the 2nd phase were concretized.

Finally, a summer workshop was held at the University of Kassel from August 29 to September 01, 2022. Participants included researchers from the [DFG research group](#) as well as members of the [international advisory board](#); Christine Musselin (Sciences Po, Paris, France), Paula Stephan (Georgia State University, USA), Maureen McKelvey (University of Gothenburg, Sweden) and Nils Brunsson (University of Uppsala, Sweden), Rajani Naidoo (University of Bath, UK), and Walter W. Powell (Stanford University, USA) made many constructive contributions to the direction of the group, to the plans for the second phase to be applied for, and to numerous publication and qualification efforts. In particular, the status of projects and empirical and theoretical research results already achieved were lively discussed.

In addition to these activities, which were directly part of the research group's activities, members of the research group were also involved in various groups and networks, where they collected ideas for the research group and disseminated results. In addition to numerous presentations, these included, for example, a panel organized by Jelena Brankovic, Georg Krücken and Raimund Hasse at the [41st Congress of the German Sociological Association](#) in Bielefeld, a panel organized by Lars Engwall, Georg Krücken and Christine Musselin at the [EGOS Conference in Vienna](#) on "The Organizing of Academia" and a panel organized by Alexander Mitterle, Tim Seidenschnur, and Roland Bloch on "How do

Universities Compete" at the [ECPR Conference in Innsbruck](#). In addition, the joint fall conference of the DGS sections Science and Technology Studies and Organizational Sociology entitled "[Competition and Organization - Comparative Perspectives](#)" took place on November 24-25, 2022, organized by Julian Hamann, Anna Kosmützky, and Anne K. Krüger.

The research group will next meet in spring 2023 to jointly advance the research on multiple competition and coordinate follow-up applications.

## New Projects

### Project Doctoral Graduates and Inventive Activities in Four European Countries ([Doc-Track](#)) started

Since September 2022, INCHER has been part of the [DOC-TRACK research](#). Together with researchers from [IPP-CSIC Madrid](#) (Catalina Martinez), the [University of Bordeaux](#) (Francesco Lissoni, Ernest Miguelez), and [Utrecht University](#) (Andrea Morrison, Fabiana Visentin), a new dataset is being built mapping the patent activities of STEM PhDs in Germany, France, the Netherlands, and Spain. The project will run three years and is funded by the Academic Research Programme of the European Patent Office.

On the INCHER side, [Professor Guido Bünstorf](#) is leading the project, [Burcu Özgün](#) and [Dr. Johannes König](#) are also involved as researchers.

### Joint project of INCHER and the University of Paderborn on "[Knowledge Transfer to and from Quality Management of Teaching and Learning at Universities \(WiaQM\)](#)" launched

The [WiaQM project](#), led by [Professor Bettina Langfeldt](#) (INCHER and University of Kassel) together with [Professor Isabel Steinhardt](#) (University of Paderborn), is dedicated to the mutual transfer processes between quality management at universities and science and higher education research. The joint project is funded by the German Federal Ministry of Science and Research. Further involved as researchers are [Julia Brose](#) and [Dr. Sylvi Mauermeister](#), Paula Sieberg as student assistant, and [Alexandra Hertwig](#) on the part of INCHER's research information service & special library.

WiaQM investigates the relationship between organizational structure, micro-policies and knowledge transfer within and beyond higher education quality management of teaching and learning. The analysis of transfer processes between QM units, the institution of higher education, as well as the scientific community is considered central to enhancing university performance, evidence-based governance, and the sustainability of WiHo research.

Methodologically, a sequential mixed-methods design is employed - a combination of bibliometric mapping and research trails, document and instrument analysis, problem-centered interviews, and a standardized online survey. The overarching heuristic used to interpret the data is Crozier and Friedberg's (1995) approach, which views organizations as collective structures created by actors and modified by micropolitics to achieve specific goals.

## Awards

### Dissertation by Oliver Wieczorek awarded the Doctorate Prize of the Universitätsbund (University Association) of the University of Bamberg

In November 2022, [Oliver Wieczorek](#) received the Doctorate Prize of the University Association of the University of Bamberg for his dissertation "[Die Universität im Feld der Macht - Zur Konstruktion von Expertise in der US-amerikanischen Wissensgesellschaft](#)" (The University in the Field of Power - On the Construction of Expertise in the US-American Knowledge Society)". The prize was awarded as part of the Dies Academicus of the University of Bamberg on 7.11.2022. This competitive prize, awarded by an external committee, not only demonstrates the academic quality of the work, but also its relevance for stakeholders outside universities.

In his [dissertation](#), published by Springer in October, Oliver Wieczorek examines the access of scientific experts to the field of power from both a theoretical and methodological perspective. The U.S. with its manifold interconnections between science, politics, administration, business, foundations, media, and the military serves as an application case.

## Ulrich-Teichler prize for outstanding dissertation theses and the GfHf-prize for outstanding Master's theses in higher education research awarded in 2022

*On September 15, 2022, two young researchers were honored for their achievements in the field of higher education research with the Ulrich Teichler award. The festive award ceremony took place during the 17th annual meeting of the [Gesellschaft für Hochschulforschung](#) (Society for Research in Higher Education) in Vienna. We congratulate the winners!*

The [Ulrich Teichler Prize](#) has been awarded since 2008. The renowned higher education researcher Professor Ulrich Teichler (INCHER) donated the prize in order to encourage young researchers to deal with questions of higher education research. At the same time, outstanding young researchers' work on this topic is to be made more widely known to the public.

Selected by a jury of seven from the 23 papers submitted were:

[Sylvie Mauermeister](#) who received the Teichler prize for her dissertation "Vom Erstsemestler zum Studenten. Herkunftsgruppenspezifische Bedingungen des Studienverbleibs nach der Studieneingangsphase an Universitäten (From Freshman to Student. Origin-group-specific conditions of study retention after the initial study phase at universities)". Sylvie, who was already a member of INCHER in the 2010s, has also been a research associate in the new [Wia-QM](#) project (a joint project of INCHER and the University of Paderborn) since September 2022.

Charlotte Schmidt received the prize for her master's thesis at the Julius-Maximilians-University of Würzburg on the topic "Inwiefern beeinflusst die Geschlechterzusammensetzung im Promotionsmentoring die Chancen für eine wissenschaftliche Karriere? Eine quantitative Analyse anhand des Promoviertenpanels 2014" (To what extent does the gender composition in doctoral mentoring influence the chances for an academic career? A quantitative analysis based on the PhD panel 2014")

The Ulrich Teichler Award for Dissertations consists of a printing cost subsidy of a maximum of 2000,- € and additionally a prize money of 1000,- €. The amount of the prize money for the awarded theses is 1000,- €. Theses submitted for the award should contribute soundly to the academic and professional advancement of university research.

The supervisors of her thesis were Professor Ulrich Teichler (INCHER) and Professor Christoph Scherrer (FB05).

#### Doctorate as positive effect of graduating from Kassel Master Program

Caroline Muasya is a graduate of the Kassel-based International Master Program Higher Education Research and Development (MAHE), which was coordinated by INCHER. In six years, from 2009 to 2015, a total of around 120 students, mainly from developing and emerging countries, took up the programme, and almost 90 graduated with a Master's degree. Caroline's successful doctorate is the latest in a series of doctorates awarded to MAHE graduates - six earned their doctorates in Kassel (the other five came from Colombia, Vietnam, China, Taiwan and Hong Kong), while more than half a dozen earned their doctorates elsewhere (from countries such as Chile, Colombia, China, Indonesia and Vietnam).

## Newly published since April 2022

### INCHER Compilation of Journals and Abstracts 2021, 2022 online

In September 2022, the compilation of relevant journals for higher education and science research by Alexandra Hertwig (INCHER, FID and Special Library) was continued with more than 3000 articles from 40 journals of the publication years 2021 and 2022. As a side effect, the freely accessible data collection "INCHER Compilation of Journals and Abstracts" provides a condensed overview of current topics in higher education and science research as well as related research areas.

The demand-oriented collection has been continuously enriched since the first volume in 2013. In addition to relevant international journals, the contributions of regional, primarily German-language journals will also be listed from the 2021 volume onwards.

As a "living reference", updates of the current volume and successive additions to older volumes are made at the end of each quarter.

Individual searches and downloads are possible in the Zotero group library. The creation of a PDF version of the annual bibliography was discontinued in 2021.
