## Welcome to our Guests at the CHER 32nd Annual Conference

INCHER-Kassel and the Consortium of Higher Education Researchers (CHER) welcome participants to the CHER 32nd Annual Conference. The topic of this year's CHER conference taking place in Kassel, from 28 August to 30 August 2019, is "Theories and Methods in Higher Education Research".

the chosen topic: The field of higher education research is growing and increasingly relying on various disciplinary and interdisciplinary theoretical approaches and advanced methods to explain higher education outcomes and policy issues. Application of theory and advanced qualitative and quantitative methods in higher education research is also significant to establish the potential and innovation of higher education research. Additionally it is important to address methodological challenges associated with international comparative research, diversity of student body, policy implementation and evaluation, secondary data usage and analyses.

Taking into account these recent developments and challenges, this year's CHER conference pursues two aims: First, critically to discuss theories and methods employed in higher education research, and second, to discuss the relevance of recent theoretical and methodological developments in other disciplines and interdisciplinary research areas for higher education research.

At the conference, research questions will be discussed from theoretical perspectives, methodological perspectives, and from the perspective of a nexus of theories and methods. Further, two open tracks will give room for those contributions that do not specifically fit with the three perspectives and are not explicitly connected to the main theme of the conference.

# Looking ahead:

## INCHER-Kassel's development strategy 2019 to 2024

In 2018, INCHER-Kassel looked back on 40 years of successful university research. Founded on June 5, 1978 (then named "Centre for Research on Higher Education and Work"), INCHER was one of four interdisciplinary research centres at the young University of Kassel. In the 1970s, academic higher education research was a novelty in German higher education. Today, INCHER-Kassel is an indispensable part of the world-wide university research landscape. INCHER's first director, Ulrich Teichler, shaped its research for more than 30 years. Following Ulrich Teichler's retirement in 2011, the sociologist and university researcher Georg Krücken took over as Executive Director. Since then, the research focus has been on the relationships between the higher education system and other societal areas – emphasizing the interfaces of higher education research with related research areas such as science, organization and innovation research.

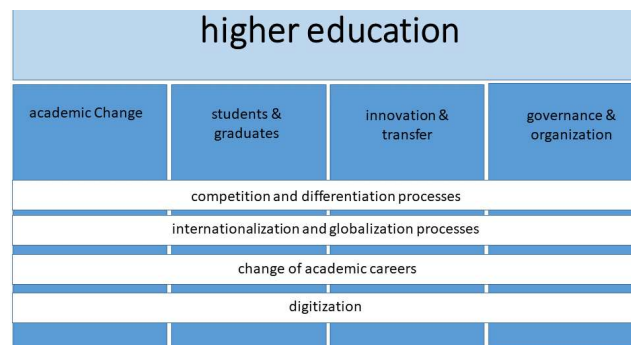
The management at INCHER decides on the development and perspectives of INCHER-Kassel and, in coordination with the head of the university, schedules them in five-year development plans. To follow are some examples from the current development strategy paper 2019-2024 showing the direction of development. The paper will also serve as the basis for the upcoming evaluation of INCHER-Kassel in 2021.

Prior to looking ahead, a quick look at the past five years shows that INCHER has succeeded in raising a total of 4.4 million euros of third-party-funding, carrying out research projects with ambitious theoretical and methodological approaches, obtaining a BMBF junior research group, and successfully establishing an interdisciplinary graduate program with six doctoral projects. Thirteen doctorates and three habilitations have been recorded over the past five years. Particularly note-worthy is that in 2018 six INCHER members were appointed to a professorship, three of them internationally.

### Fundamental Orientation of Research: Higher Education and Society – Reform Processes and their Impacts

The starting point for higher education and science research at INCHER is the socio-theoretical and macro-perspective supported assumption that higher educa-

tion institutions are embedded into society. This results in looking at the higher education system as a whole, at its internal structures and its relationship to other areas of society. The combination of specific functions and missions of the universities, together with openness to the environment, leads to forms of governance and organization that are typical of higher education institutions and that are constantly changing. Thus, the four main research areas of INCHER are justified: academic change, students and graduates, innovation and transfer, as well as governance and organization. Each of these four research areas at INCHER-Kassel is led by a senior researcher.



Since the 1990s, in all four research areas, internal and external reform processes and their consequences affect research, teaching, transfer, governance, and

organization. Of particular importance for the analysis are non-intended consequences. These consequences are examined at INCHER with analytical distance and with a broad arsenal of social science theories and methods. The consistent development of theory and methods in recent years will continue to characterize research at INCHER.

### A matrix of research areas and thematic foci guides INCHER's research strategy

In addition to the four main research areas, INCHER research will include the following four thematic foci as strategic priorities in the coming years: a) competition and differentiation processes in the higher education system, b) impact of internationalization and globalization processes, c) changing academic careers, d) digitization.

### New developments in the four research areas

Over the next years, two central research topics will be dealt with in the research area "Academic Change." Both are positioned beyond the mainstream of higher education and science research. The first is: "social organization of academic misfits": In science, it is not uncommon that different and/or deviant social characters, which provide for change or innovation, set genuinely new research topics, dare to carry out risky research, or seek new ways of knowledge communication while questioning the obvious. The second research area focuses on in-creasing "theatricalization" or "dramatization" of science and in social contexts. Both

research projects claim an international dimension, refer to current debates, are compatible with the canon of previous science and university research, and are also innovative.

The research area "students and graduates" will focus on students with educational disadvantages. By focusing on this area, it will be possible to gain a better understanding of the inequalities in higher education and academic success. We will use innovative methods, such as network analysis and (quasi-) experimental studies. The current project BUKSS (Social Inequalities and Dropout and Change of Study Programme) is an important element of this research area. It will be continued and further developed. Furthermore, new research is also planned in the field "Study success and health". This research will be more exploratory in character as there is a lack of theoretically and methodologically sound interdisciplinary research on students with health impairments in Germany. In addition, the data collected in the Cooperative Project Alumni Studies (KOAB) for the grades 2008-2016, should be used for evaluation projects to improve their current unexploited scientific potential for INCHER and the scientific community as a whole.

The research area "innovation and transfer" will look more into the consequences of higher education reform on social innovation in research, which manifests itself in the form of publications through a constantly changing governance and through indicator-driven metrification of the research output. International comparative research will continue to be prominent in the transfer section. The acquisition of knowledge in the transfer process was the focus of the survey "The Academic Professions in the Knowledge Societies (APIKS)" which was completed in 2018. APIKS was conducted in more than 30 countries from all five continents. Findings from the APIKS project will influence a planned binational research project on knowledge and technology transfer.

The fourth research area, "Governance and Organization", is based on extensive preparatory work at INCHER-Kassel on changes in governance and organization of higher education. Research on the role of external consultants for the governance and organizational development of universities (DFG project LegU until 2018) will be further developed in the light of the relationship between universities and society. In addition, the importance of counselling as part of a society trend with a view to universities will also be examined.

The question of the role of universities as actors in a crisis-ridden Europe was examined in a project on higher education and Brexit and will be followed in the next years in further publications.

Further international collaborative research is planned on the institutional responses of universities to changes in the scientific system. This research focuses on connections between organizational processes, decisions and developments in the field of education under organizational framework conditions that are becoming more diverse.

### **Competition and differentiation processes in the higher education system as a thematic focus**

In many respects, higher education is a highly competitive field and competition is growing. Therefore, INCHER-Kassel decided to establish a thematic focus "processes of differentiation and competitiveness in the higher education system". For this, a full application for a DFG research group will be submitted by the end of 2019. A multi-institutional, interdisciplinary group consisting of nine individual projects will focus on "multiple competition in the higher education system: actor constitution, action coordination and effects" (Speaker: G. Krücken, Deputy Speaker: G. Bünstorf). This group could also serve as a nucleus for further third-party funded projects and PhD or Master's theses.

### **Digitization is a central topic**

The future thematic focus "digitization" is central in two respects. On the one hand, new technologies are changing higher education and science systems dramatically. On the other hand, research in higher education and science also benefits from technical developments. Ongoing research projects on the digitization of higher education and science systems at INCHER-Kassel, are "MOOCs after the Gold Rush" (MOOC-AG)". This project examines the market dynamics of Massive Open Online Courses (MOOCs) and the strategies of suppliers in the market. The research is based on economic and social science theories and also considers the legal dimension of open online courses, and the new INCHER project "Showing Life Opportunities (SLO)". This project examines the effectiveness of digital teaching formats in supporting start-ups by carrying out a large-scale randomized field experiment with around 25,000 pupils in Ecuador. This project is funded by, among others, the World Bank and the UK Innovation Growth Lab. Further collaborative international and national grant applications are on their way.

### **Fostering talent – promotion of young researchers**

INCHER's successful strategy of promoting young researchers, which is unique in Germany, will be continued and further developed. In addition, on the basis of experience with the graduate program ELBHA, the application for



a graduate program, probably at the DFG, is planned for 2021. This will be carried out in cooperation with the Leibniz Center for Science and Society (LCSS) at the University of Hanover and the German Centre for Higher Education Research and Science Studies (DZHW). In terms of content, the project will deal with overarching questions of higher education and science research. In addition, two junior research groups will be established at INCHER-Kassel.

### Networking

The INCHER is already well connected at a national as well as at international level, as highlighted by the CHER conference at INCHER and by the project "Showing Life Opportunities", in which INCHER cooperates with HEC Paris, ENSAE, Ecole Polytechnique, Warwick Business School and the research department of the World Bank. In addition to further international research cooperation and to further increase of international

networking over the next five years, at least two Alexander von Humboldt (AvH) scholarship holders will be invited as visiting scholars to INCHER. Other regular exchange activities that will continue to contribute to networking are INCHER senior researchers staying at universities abroad and visiting scholars staying at INCHER. Furthermore, the regular research visits will continue by the Executive and Deputy Managing Directors, Georg Krücken and Guido Bünstorf, at Stanford University's Scandinavian Consortium for Organizational Research (SCANCOR).

Moreover, Guido Bünstorf extends his status as a visiting professor at the Institute of Innovation and Entrepreneurship (IIE) at the School of Business, Economics and Law at the University of Gothenburg (Sweden), which is particularly renowned in the field of science economics and university-industry relations.

# New project starts on quality assurance and quality development in dual study programs

The project examines the current process of quality assurance and quality development in dual study programs in Germany. The process happens between the poles of different institutional and actor-related interests as well as against the background of divergent concepts of quality.

Research on this topic is important because the hybrid qualification format has experienced rapid quantitative growth over the past ten years and is becoming more differentiated. However, student and graduate surveys provide evidence that the expected good theory-practice-link, the conception of the practical phases as well as the learning support and documentation of the qualification in

the companies could be improved in some places.

The project aims at new and more data-based insights into the interplay in which structural and organizational as well as subject- and industry-specific factors influence quality assurance in dual study programs. For this purpose, an integrated multidimensional and multi-perspective mixed-methods-design is used, which is based on the combination of various qualitative and quantitative techniques of data collection and data analysis to define more precisely the degree of coherence between formal requirements and regulations concerning the quality assurance of dual study programs on the one hand and

subjective theories and practices of the actors involved on the other.

Major goals are a) to identify problem areas of quality assurance and b) to find "best practice solutions" for quality assurance and quality development and reflect on them. Based on project results, a transfer of knowledge is planned to universities, universities of advanced studies, and universities of cooperative education as well as the related companies, regional umbrella brands of dual study programs, chambers, and educational policy-makers.

# Ulrich Teichler Prize 2019 for young higher education researchers awarded

Two prizes were awarded on March 21, 2019. Both prizes were donated by Ulrich Teichler and these were the Ulrich-Teichler-Prize for outstanding dissertations and the Gesellschaft für Hochschulforschung prize for outstanding degree theses in higher education research in 2019.

Two junior researchers were awarded the prizes for their contributions to higher education research. The ceremony took place at the 14th annual meeting of the German Society of Higher Education Research (Gesellschaft für Hochschulforschung, GfHf), from 21 to 22 March 2019 at the Otto von Guericke University in Magdeburg.

The prize winner of the Ulrich Teichler Prize for dissertations receive a printing subsidy for 2000 euros, plus 1000 euros prize money. The author of the award-winning degree theses receives a prize of 1000 euros.

The Ulrich Teichler Prize was awarded for the first time in 2008. The higher education researcher and former INCHER-director Prof. Dr. Dr. h.c.

Ulrich Teichler has donated the prize to encourage young scientists to examine questions of higher education research in a scientific manner. At

the same time, the innovative work on this subject by young researchers should be better represented to the public. Until 2013 the initiative was supported by the Bundesministerium für Bildung und Wissenschaft (BMBF).

Out of the 21 submitted works, the following award winners were selected by a six-member jury:

Grit Fisser for her dissertation on the topic "Wahrnehmung biographischer (Un-)Sicherheit bei "Postdocs" at Leibniz University Hanover, Lea Goldan for her master thesis on the

topic "Lohnt sich eine Promotion für Frauen und Männer gleichermaßen? Eine Analyse geschlechtsspezifischer Lohnunterschiede unter Promovierten auf Grundlage des DZHW-Absolventenpanels", also at Leibniz Universität Hannover.

Doctoral candidates and graduates of German-speaking universities (A, CH, D, LI, LU) can apply for the awards. To apply, candidates need a well-founded contribution to the professional development of higher education

research. Authors do not have to be a member of the Gesellschaft für Hochschulforschung. The works submitted will be judged by a jury comprising researchers from various disciplines who are appointed by the executive board of the Gesellschaft für Hochschulforschung.

The coming annual conference of the Gesellschaft für Hochschulforschung will take place at Hamburg Center for University Teaching and Learning, University of Hamburg, on March 26 – 27, 2020.

## PhD students benefit from GfHF mentoring program

INCHER member Isabel Steinhardt organizes a Mentoring Program for the German Society of Higher Education Research (GfHf) and also leads workshops connected to the program. In an article for the GfHf newsletter 2019, she takes stock of the Mentoring Program's development.

Since 2013, the Program has been supporting PhD students in the field of higher education research. It helps

them to find their place in the field and to connect with the academic community. It provides opportunities for informal knowledge exchange and experience as well as support in strategic questions such as career planning. An evaluation of the mentee year 2017 shows: none of the mentees have canceled her or his doctorate so far, although some faced difficulties. One third of the

mentees will complete their doctorates this year; the others next year. Various articles have been discussed and published. Isabel Steinhardt sums it up to: "All in all, a very positive conclusion can be drawn that makes the voluntary commitment of all people involved to support young university graduates worthwhile (...) Many thanks to all who are involved in the success of the program!".

# The Consortium of Higher Education Researchers (CHER) after Three Decades

In 1988, the Consortium of Higher Education Researchers (CHER) was founded as the first international association of its kind. Up until today, CHER has remained the only academic association with a world-wide net of members focusing on theories, methods and systematic knowledge on higher education.

A conference held in Kassel in 1988 on the state of higher education research, supported by the Volkswagen Foundation, brought together around 50 scholars from different countries. The visiting scholars saw the need to establish regular international communication between higher education researchers.

joint comparative research: Certainly, CHER's most visible success is the increase of comparative research projects and the role CHER members have played to initiate such projects.

Over the years, CHER strengthened its activities to be an important arena of communication for young researchers. After some years,

CHER also initiated a book series, which included valuable conference contributions on the annual key themes.

Annual conferences were held in many countries, but the backbone of CHER was a limited number of sizeable research centres in Europe. The conferences were held in Kassel in 1988, 1998 and 2006. In August 2019, INCHER-Kassel will host the fourth conference in Kassel with around 200 scholars from more than 30 countries. The conference theme "Theories and Methods in Higher Education Research" reminds us of the reflections three decades ago. These reflections were how, higher education research, a field bound to strike a balance between academic thrusts and social relevance, needs thorough debate among scholars on theories and methods. In having this debate, research will not be overwhelmed by policy discourses, political fashions and practical problem-solving expectations

CHER members have done their best over the years to strengthen a collaborative spirit and thus facilitate

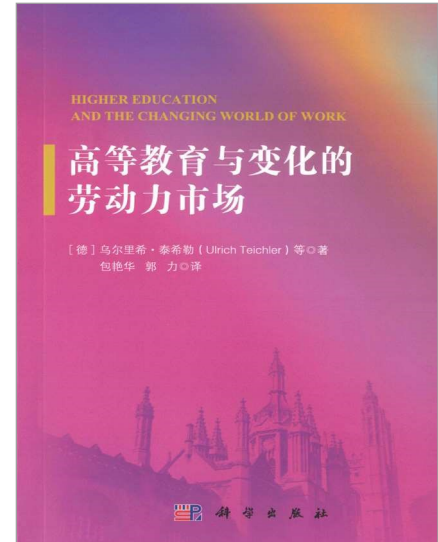

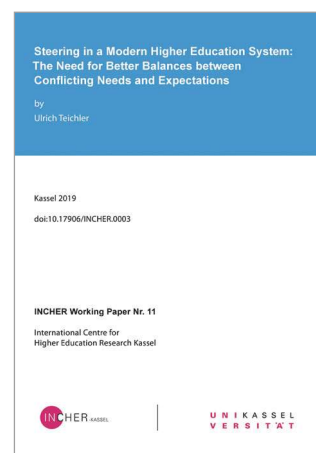
## Ulrich Teichler (2018): Steering in a Modern Higher Education System. Kassel: INCHER-Kassel (INCHER-Working Paper no. 11)

In this INCHER-working paper, Ulrich Teichler analyzes the character of steering in higher education and its impact in the academic domain. The paper has a special focus on developments in economically advanced countries over a period of more than five decades. He presents an overview of the core substantive issues, which are predominantly targeted by

the steering system. Subsequently, the strengths and weaknesses of the current major steering approaches are assessed by looking closely at the academics’ views: How they assess the current steering system, can be illustrated by the findings of an international comparative study of the academic profession, quantitative, structural and organizational

relationships between higher education and employment.

## Special Issue of Higher Education Policy on 20 Years of Quality Assurance in German Higher Education appeared

The special issue edited by Christian Schnejderberg on “Taking Account of 20 Years of Quality Assurance in German Higher Education” provides insights into research on the consequences of political higher education quality reforms in Germany.

The four papers presented in this mini special issue address different aspects of the German higher education accreditation regime. The empirically evident consequences studied in the contributions are diverse: Schnejderberg and Steinhardt did a normative

coding of the multiple versions of accreditation criteria to show how criteria for the standardization of the organization of studies and teaching, and HEI quality management are reduced under political pressures, such as the collective protest by the rectors’ conference and student protests. Baumann and Krücken focus on events and present documented evidence on academic resistance, which challenges the internal and external legitimacy of HEAR. Lust, Huber, and Junne present an interview study about how professors use academic

identity claims as a means to resist managerial changes pursued by HEAR and other quality assurance mechanisms. How quality managers deal with the resistance of academics is presented in the quantitative study by Reith and Seyfried.

# Mourn for Yoko Teichler

INCHER-Kassel members are deeply touched and saddened by the news of the death of Yoko Teichler-Urata, who passed away on 16 March 2019.

Yoko Teichler-Urata (born 1943) studied sociology and cultural anthropology at the International Christian University Tokyo, Japan. As a student she became involved in interpreting and translation, most notably for the 1964 Olympic Games in Tokyo and for the World Peace

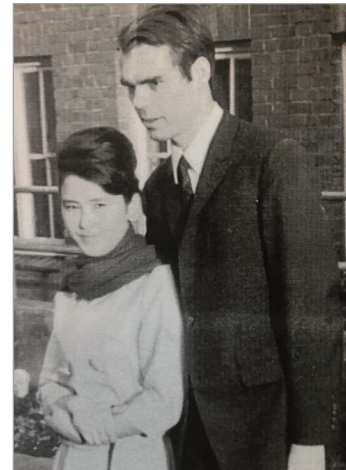
Mission in 1964 that brought survivors of Hiroshima and Nagasaki to the US and Europe – including Berlin. Here she met her future husband Ulrich Teichler, whom she married in 1966. Their sons, Nils-Erik Shinichiro and Matthias Tim Yoshio, were born in 1967 and 1969.

When the family moved to Kassel in 1978, Yoko began a 30-year career as a simultaneous conference interpreter. Her outstanding abilities quickly led to accreditation by the AIC, the world-wide association of top interpreters. For many years, she was considered one of the most important interpreters in Europe for German-Japanese and English-Japanese.

Alongside her own professional commitments, Yoko Teichler also provided invaluable support in the development of the Centre for Research on Higher Education and Work at the University of Kassel (today INCHER-Kassel), of which her husband was founding director. She contributed

significantly and in many different ways to the internationality of the Centre. Yoko accompanied her husband to numerous international conferences and was highly popular, both as an insightful partner in conversation and as an ever charming and gracious hostess. International guests, students and members of the University of Kassel will especially remember her warm-heartedness, generosity and kindness.

Yoko Teichler will be greatly missed by everyone who knew her and will always be in our memories. Our deepest sympathy goes to Ulrich Teichler, his sons and the entire family.

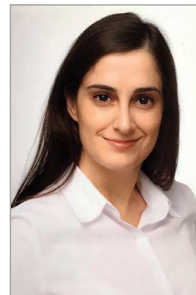
