### Directive on the official and private use of telecommunications facilities in the state administration (Telecommunications Directive)

#### 1. Scope

##### 1.1 Spatial

1.1.1 These regulations govern the official and private use of official telecommunications facilities of the Hessian state administration by employees while maintaining the confidentiality of the spoken word.

They also apply to employees in alternating teleworking, insofar as a telecommunication connection is made available by the department.

They apply accordingly to external employees, provided they have access to company telecommunication facilities.

With regard to the use of telecommunications facilities outside the Hessian state administration, the scope of this guideline is extended to include the regulations mentioned in points 2.2, 2.3 and 3.5.

1.1.2 The directive does not apply to members of the state government, state secretaries.

The directive does not apply to judges and public prosecutors unless they perform exclusively executive duties. The Hessian Ministry of Justice, Integration and Europe will issue its own regulations for these employees, if necessary.

The directive does not apply to special telecommunications facilities for security tasks in the area of the police, at the State Office for the Protection of the Constitution and security-related facilities in the area of the administration of justice.

1.1.3 For the transmission of classified information by telecommunication, the rules and regulations issued in the Classified Information Instruction

VS telecommunication guidelines as amended from time to time must be observed.

## 1.2 Objective

Telecommunications equipment means technical equipment with fixed or mobile terminals for telephony.

## 2. Business use

2.1 The use of official telecommunications equipment is generally permitted only for official purposes.

As a rule, dialing international numbers or premium-rate numbers is not permitted. These are to be blocked as far as technically possible and economically feasible. In justified exceptional cases, the blocking may be lifted for individual employees or groups of employees.

2.2 If official calls have to be made from third-party telecommunications equipment, the costs are to be reimbursed to the third party against receipt. If costs for official calls are incurred on the occasion of the performance of official business away from home, they shall be reimbursed in accordance with Section 11 of the Hessian Travel Expenses Act.

2.3 If official calls from an employee's private telecommunications equipment become necessary, the costs are to be reimbursed if the employee can substantiate the costs by recording the day, call participant and duration of the call as well as the determined amount of the costs.

2.4 In the event of the employee's absence, a telephone substitute must always be provided, for example by activating automatic forwarding.

## 3. Private use of location-based terminals

3.1 The private use of location-based terminals during working hours is permitted to a minor extent, provided that official matters are not impaired and the declaration of consent enclosed has been submitted in writing in advance. Official concerns are opposed if the private use is likely to impair the business operations, in particular due to the duration of the telephone call or the limited availability for business purposes.

If consent to the logging of private use of the telephone system is not given, private use is expressly prohibited. Permission to use the telephone system for private purposes or to use it free of charge is subject to revocation. Such revocation may be declared if there are concrete indications of private use contrary to the above principles. The relevant staff council must be informed in advance of this decision.

3.2 Dialing international numbers and special numbers for private purposes is prohibited. Dialing toll-free special numbers is permitted.

3.3 Private use can be signaled by dialing a special identifier. In this case, the connection data is stored in accordance with Section 5.1.2.

3.4 In principle, private use is not billed. If a department does not have the option of flat-rate billing, private use may be billed in exceptional cases. In this case, the data pursuant to Section 5 will also be recorded for billing purposes.

3.5 In the case of incoming calls of a private nature, care must be taken to ensure that official matters are not impaired, in particular by the duration of the call. This also applies to calls of a private nature made during working hours using private mobile devices brought along by the employee.

3.6 Fax machines and business telecommunications equipment at home workplaces are generally excluded from the permission for private use.

## 4. Mobile devices

4.1 Mobile terminals can be provided if the official interest is determined. The necessity for the provision of the device must be documented when the device is assigned. A further examination of the official interest is only required if the employee's performance of duties has changed.

employee is required. For mobile communications, the costs and connection data are collected directly by the external provider and made available to the service.

4.2 Instructions for use (in particular proof of the individual devices and cards, the respective authorizations and possible risks of use, especially with regard to possible unexpected costs) must be developed and their acknowledgement by the respective employee must also be recorded. When using mobile devices, particular attention must be paid to the increased risk of eavesdropping.

4.3 The private use of business mobile devices is generally prohibited - except in dangerous situations - unless the different uses can be separated via business and private identifiers and the private use can be settled directly between the employee and the mobile communications provider or this is already covered in the corresponding contract. For incoming calls of a private nature, digit 3.5 p.1 to be observed.

## 5. Control

### 5.1 Control data; control purpose

To verify compliance with the Directive, the following connection data is stored, if technically feasible, by means of an automatic data collection system for both fixed and mobile terminals:

5.1.1 For on-duty calls for each call:

- the extension number
- the destination number without the last 3 digits
- Date and time (start and end of the call)
- the units of charge

5.1.2 For private calls for each call with a location-based terminal :

- marking the conversation as private
- the destination number without the last 6 digits
- The same data as for official calls is used for the rest

The resulting data is used for statistical evaluations in accordance with Section 5.2. Beyond that, there is no performance monitoring of employees and, in particular, no linking with other files. The logging does not record incoming telephone calls within the meaning of Section 7 (1) HPVG.

### 5.2 Statistical evaluations

Statistical evaluations of telephony volume based on the stored data are performed without reference to individuals and exclusively for the implementation of internal, planning and organizational measures, such as the determination of capacity utilization and the ratio of fixed-network to mobile telephony. The results are to be communicated to the local staff representatives at their request.

### 5.3 Data deletion

5.3.1 Storage of connection data for more than six months after the end of the respective month is not permitted.

5.3.2 Within this maximum storage period, the connection data must be destroyed or deleted immediately as soon as it is no longer required for evaluation and control purposes.

### 5.4 Exceptions from the control

As far as technically possible and economically feasible, the log data of the telephone calls made by employees in the performance of certain special tasks (e.g. telephone calls made by staff representatives, women's representatives and shop stewards for disabled persons) or in their capacity as persons subject to professional secrecy must be kept confidential.

-The data of the caller should not be recorded in the sense of Section 203 of the German Criminal Code (StGB), but the calls in question should be identified by dialing a code number within the scope of the special task in order to suppress the storage of the telecommunications data and to exclude an evaluation in accordance with Section 5.2.

If the possibility of marking does not exist for technical or economic reasons, the official calls of employees with a special function are not recorded and evaluated as a whole.

Calls marked as private are covered by the storage according to Section 5.1.2.

#### 6. Transition period

The Directive shall enter into force upon its publication. It must be implemented no later than six months after its entry into force.

#### **Third collective bargaining agreement dated April 24, 2013 for the implementation of § 12a NV Bühne of October 15, 2002**

the following collective bargaining agreement is concluded:

#### § 1

(1) This collective agreement shall apply to members who fall within the scope of the NV Bühne and to whom § 12a NV Bühne applies by collective agreement, provided that the members have a contract of employment with an employer who applies the TV-L (hereinafter: Tarifbereich TV-L) or the TVöD-VKA (hereinafter: Tarifbereich TVöD).

(2) If an employer does not apply either the TV-L or the TVöD, this collective agreement shall apply in addition to subsection 1, provided that the regulations of the collective bargaining area to which the employer has committed itself on the basis of the TV-L shall apply.

§ Section 1 (2) of the Second Collective Agreement of July 1, 2008 on the Implementation of the Adjustment Provisions of the NV Bühne of October 15, 2002, unless otherwise stipulated in Section 3.

(3) The collective agreement does not apply to members who have an employment contract with a private theater (§ 1 para. 7 subpara. 2 NV Bühne).

#### § 2

(1) The salaries of solo members and stage technicians who have an employment contract with an employer in the TVöD pay scale will be increased by 1.4 percent as of January 1, 2013, and by an additional 1.4 percent on August 1, 2013.

(2) The salaries of solo members and stage technicians who have an employment contract with an employer in the TV-L pay scale area will be increased by 2.65 percent as of January 1, 2013.

(3) The salaries of opera chorus and dance group members who have an employment contract with an employer in the TVöD pay scale area will be increased by 2.65 percent as of January 1, 2013, while maintaining the salary class.

The compensation in the amount of 1.0 percent of the monthly salary pursuant to § 2 para. 3 subpara. 2 Second Collective Agreement of June 14, 2012 for the Implementation of § 12a NV Bühne of October 15, 2002 shall cease to apply upon entry into force of this Collective Agreement.

These opera chorus and dance group members will receive from the October 1, 2013 again received compensation in the amount of 1.18% of the monthly salary. The compensation is part of the salary.

(4) The salaries of opera chorus and dance group members who have an employment contract with an employer in the TV-L pay scale area will be adjusted, while maintaining the salary class, from the January 1, 2013 by 2.65%.

(5) When calculating the fees or fee classes of the opera chorus and dance group members, any cent amounts of 50 and more cents shall be rounded up to full euros, and amounts of less than 50 cents shall be rounded down to full euros, subject to the proviso that there must be a difference of 1 euro between the upper limit of a fee class and the lower limit of the next higher fee class.

(6) In application of paragraphs 3 and 4, from January 1, 2013, for the TVöD pay scale and for the TV-L pay scale the monthly salaries in the salary class shall be as follows

1a from 3 . 034 Euro

1b from 2,962 euros to 3,033 euros

2a from 2 , 713 euros to 2,961

euros 2b from 2 , 281 euros to

2,712 euros (remuneration

increased by 2.65 percent)

(7) § Section 76 (2) and Section 89 (2) NV Bühne shall be amended in accordance with the Paragraph 6 amended.

(8) The grandfathering allowance pursuant to § 3 paras. 2 and 3 of the Second Collective Agreement of January 15, 2006, amending the NV Bühne of January 15, 2006, shall be paid as follows October 15, 2002 will be increased by 1.4 percent on January 1 in the TVöD 2013 pay scale and by a further 1.4 percent on August 1, 2013, and by 2.65 percent in the TV-L pay scale on January 1, 2013.

#### § 3

(1) For members who have an employment contract with a Hessian State Theater, the City Theater of Giessen or the Hessian State Theater of Marburg, § 2 paragraph 2 and paragraphs 4 to 8

shall apply.

(2) For solo members and stage technicians who have an employment contract with the Nuremberg State Theatre, § 2 of the employment contract shall apply.

## Telecommunication

### s service agreement

The following service agreement is concluded between the University of Kassel, represented by the President, and the Staff Council:

#### 1. Scope

This service agreement regulates the use of official telecommunications facilities at the University of Kassel. It applies to all employees of the University of Kassel. Telecommunication facilities are technical equipment with fixed or mobile terminals (especially telephone terminals of the type Cisco CP-6941). The department shall ensure that disabled staff members (especially those with hearing and visual impairments) are guaranteed largely unrestricted use.

The following hardware and software is used: Cisco Systems Communications server UCS and the evaluation software Aurenz.

The data stored in the telecommunication device may not be used for behavioral, performance or presence control. The data is stored solely for the purpose of automated load balancing, system troubleshooting and billing.

Recording and listening to conversations is not permitted.

#### 2. Standard performance features of the end devices

The system has the following standard features:

- Display names of participants
- Call duration display
- Hold, Flaw, Call Waiting
- Redial, redial list
- Call forwarding, call forwarding, callback request
- personal address book
- Caller list
- 3-way conference (inclusion of one more participant after attention tone)
- Phone lock (with personal PIN)

The standard features are available after commissioning of the terminal equipment. Users can activate or deactivate the following standard features themselves:

- Answering machine (voicemail box incl. voicemail mailbox, listening to messages with PIN, possibility of limiting the storage time of voice messages)
- Computer Telephone Integration, CTI (program for controlling telephone functions/features via the computer, dialing support through the applications supported by the IT service center, support during the call).
- Fax server connection

#### 3. Unlocking additional features

Upon request by the user, the following features will be activated by the IT service center, specifying the cost center:

- Team function (call number transfer for pending calls of own team group, optical / acoustic information for unanswered calls of own team group)
- Chief Secretary Function
- Call forwarding to external
- Phone number identification (name resolution after matching with mail client)
- Audio conference with more than 3 participants
- One-number service (reachability under one phone number, integration of a GSM terminal into the TC solution, integration of mobile terminals)
- Freeseating (logging in with own user profile from another terminal device)

#### 4. Call Center

The call center combines the following functionalities:

- Load distribution  
"Last Agent Call", i.e. booked-in employee of a group who has not had a call for the longest time is assigned the call. A post-processing time, during which no calls are assigned, can be activated.
- Agent login and logout  
Call center employees can log out of the call center at any time to carry out other activities outside the call center.
- Booked call center employees receive the following information:  
Number of logged-in employees incl. status (call, free, incoming call, follow-up), number of pending call center calls, average waiting time in queue (optional).
- Monitoring  
Call center monitoring is used to determine and display the current status of call center utilization. The monitoring is group- or call center-related; conclusions on individual persons are to be excluded as far as possible.
- Reporting  
Call center reporting is used for subsequent evaluation of the call center's utilization status.

Further evaluations are only carried out by the IT Service Center with the consent of the Staff Council. The evaluations and reports are only collected in anonymous form. Within the framework of Section 62 (2) of the Hessian Staff Representation Act, the Staff Council has the opportunity to inspect the reports.

The following call centers are currently in place:

- Department of Studies and Teaching, Student Services,
- IT Service Center, IT Service Desk.

If additional call centers are set up, they shall also be subject to the provisions of this service agreement.

## 5. Briefing for staff

As part of the rollout, user-specific training sessions will be held for administrators, employees at the operator workstations, and employees at the call centers. All other users will be informed about the functionalities with the help of online brief instructions and train-the-trainer activities.

## 6. Functionalities offered by other solutions

The video conferencing function is implemented outside the system described above.

## 7. Private use of location-based terminals

Private use of location-based terminal devices during working hours is permitted to a limited extent, provided that official matters are not impaired and the declaration of consent (Annex 1) has been submitted in writing by the employee in advance. Reference is made to the Guideline on the official and private use of telecommunications facilities in the state administration (Telecommunications Guideline) of June 21, 2013 (Official Gazette 29/2013 p. 890). The declaration of consent is handed out to new employees when they are hired. Private calls are to be marked with the identifier "99".

## 8. Charge data collection and evaluation

The following features are stored for outgoing business and private calls:

- Extension number
- Date
- Time (start and end of the call)
- Destination number (for business calls, the last three digits are deleted, for private calls, which are to be identified with the identifier "99", the last six digits are deleted)
- Duration of the conversation
- Charge units of the call (if information is transmitted, provider-dependent) Call data is deleted

after 100 days at the latest.

Of the extension and mobile phone connections of the members of the Staff Council, the representatives of the severely disabled and the women's representatives, only the monthly totals of the charge units are recorded (special authorization).

## 9. Deviating regulation for people with disabilities

Special individual regulations (e.g. allocation of performance characteristics) can be made for people with disabilities which deviate from the service agreement. These must be applied for and determined with the participation of the representative body for the severely disabled.



## 10. Security and data protection

The procedural directory in accordance with Section 6 of the Hessian Data Protection Act is part of the service agreement.

## 11. Entry into force, termination

This service agreement shall enter into force on 01.07.2015. It replaces the service agreement dated July 31, 2014.

The service agreement may be terminated by giving three months' notice to the first day of a month. Termination must be in writing and must be justified. Until a new regulation comes into force, the service agreement shall continue to apply within the scope of its after-effect.
